### **AQHA ENTRY INFORMATION & REMINDERS:**

- **AQHA MEMBERSHIP CARDS** - No Joint, Corporate or Ranch Card Nos. may be used to exhibit (ride) a horse in AQHA. Exhibitors must have one of the following individual cards that are current and not expired. Memberships may be purchased before the show online at AQHA.com (bring confirmation page), or at the show:
  - AQHA Regular (Open)
  - AQHA Amateur
  - AQHA Youth
- **AQHA CLASS AND OPEN AQHA SIDEPOD ENTRIES:** Must check in at office before barrel race begins to provide horse registration paper and membership copies (we can keep), as well as to pick up AQHA back number for AQHA Classes!
- **AQHA JUNIOR AND SENIOR HORSE ENTRIES:** Enter your horse based on horses age as of January 1 of the current calendar year.
- **AQHA YOUTH ENTRIES:** Enter your Youth Member based on the youth age as of January 1 of the current calendar year.
- **AQHA DRAW:** Jr, Sr, Amateur, Amateur Select and Youth all run in one big draw. Computer separates your run by division. If you also enter Open 5D you will carry your AQHA time to open.
- **AQHA MEDICATION REPORTS** are available at the show office to declare any medications administered in equine scheduled for AQHA competition. This is your responsibility as an exhibitor to declare medications. Failure to do so could result in a disqualification. AQHA does not notify shows that are randomly selected for drug testing; however, they have appeared at multiple Tri-K events, and we will support their efforts if requested. Please reference the AQHA Handbook for allowed medications and reporting requirements.
