Special Needs Class: All Ages. Class is based on straight time, no D's. FREE ENTRY FEE – PRIZES AWARDED.

Beginners: 14 & Under Beginners (ponies, trotters & Lopers...cannot enter in other classes). Entries will be allowed to stay in Beginners until they run a time equivalent to placing in the Open 5D twice. Ability based on rider not the horse. 5D is full second splits.

PBRIP Entries: \$10 of entry goes to APHA per program requirements.

Canadian County Sidepot Entries: Must be a resident within Canadian County boundaries.

Exhibitions: \$5 ea. and sold on site, first come first serve day of race. Scheduled in 30-minute increments. **You have a better chance of getting an exhibition if you come early. Late 30-minute sections sell out first.** No refunds or credits for no shows.

Substitutions: ALLOWED UNTIL ONE HOUR BEFORE RACE BEGINS (6pm). You MAY NOT sell your entry to someone else, however, you may draw yourself out and apply your fees to their run. (A new number will be drawn for them at that time). Another barn fee may be required depending on if the person has already entered for that day or not.

Refunds: ALL REFUND REQUESTS MUST BE SUBMITTED AT LEAST ONE HOUR BEFORE RACE BEGINS (6pm). Must have a Vet Out or Dr Release for refund, and subject to approval by management. Office Charges will be retained for benefit. Entries via credit card will not be refunded convenience/service fees charged by online and/or credit services as well.

Health Requirements per State Law: Negative Coggins Required for all horses; Out of State Horses require 30 day Health Certif.

Entry Methods and Deadlines: Only cash and credit cards accepted day of show. Checks accepted with mail in entries only. We do not accept Text Entries. 75% Payback unless noted otherwise above.

- **Online Entries:** It is HIGHLY RECOMMENDED you enter online via our website link to www.fastenter.com. Online will close Monday, August 23, 2021 at midnight for pre-draw deadline processing.
- **Mailed Entries:** Also HIGHLY RECOMMENDED...Postmark deadline for mail in entries with checks or credit card is Saturday, August 14, 2021 (\$30 Returned Check Fee). If you choose to pay by Credit Card, please include the Credit Card Authorization form info (subject to non-refundable convenience fee). **ENTRY FORM MUST BE SIGNED ON ALL ENTRIES, OR WILL BE RETURNED!**
- **Walk Up Entries:** Special Needs and Beginners must be entered by 6pm. Open 5D can late enter until 8pm. NO LATE FEES!

Pre Draws and Results: Posted on www.fastenter.com once confirmed. Pre-Draws should be posted on or before Wednesday before race. Please note all late entries may not appear on Pre-Draw posting if entered after pre-draw deadline of August 23, 2021. We post updated draw 30 minutes before each class the day of the race. If you need to know earlier, please check in at office.
